<b>C. ATHLETE ELIGIBILITY</b>

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions). Only those athletes who comply with the Olympic Charter may participate in the LA28 Olympic Games (the “Olympic Games”).

<b>D.1.</b> <b>16 (1 team)</b>	<b>Host Nation – United States</b> The Olympic Games host country will be allocated one quota place on the basis that the men’s team has satisfied the FIH criteria of appearing on a ranking of 25 or better in the FIH World Rankings since the end of the Paris 2024 Olympic Games.
<b>D.2.</b> <b>32 (2 teams)</b>	<b>FIH Hockey Pro League</b> The highest placed nation in the FIH Pro League Season 7 and FIH Pro League Season 8 will earn one quota place each for their NOC. If the same team that wins Season 7 also wins Season 8, the quota place will be offered to the runner up of Season 8.

D.4. 64 (4 teams)	<p><b>FIH Olympic Qualification Tournaments</b></p> <p>There will be two FIH Olympic Qualification Tournaments, consisting of eight teams each (16 teams in total), held in early 2028. The tournament format will be the same as that used for the 2024 FIH Olympic Qualification Tournaments, with two pools of four, then semifinals and a final. The top two teams in this tournament will earn one quota place each for their NOC.</p> <p>If the host nation is the highest placed nation in the FIH Pro League or in the 20th Pan American Games in 2027 in the men's competition, then a fifth quota place will be available in the FIH Olympic Qualification Tournaments. This will be offered to the highest world ranked of the two teams who finish third in the two FIH Olympic Qualification Tournaments, at midnight on the final day of the second tournament to finish.</p> <p>The teams invited to participate in these tournaments will be based on continental quotas as set out below. Such invitations will be made after midnight on the final day of the last continental championships.</p> <p>The continental quotas will firstly be determined by the number of nations from each continent that are among the top 24 Olympic-eligible nations in the World Ranking.</p> <p>Note: as Great Britain takes part in the Olympic Games, only one British nation – England – will be considered as part of the quotas. Any other nation falling under Great Britain will not, and therefore if any are also ranked in the top 24 of the World Rankings, then the nations ranked in 25 or 26 will be used to calculate the quotas.</p> <p>From these 24 quotas, the continents of the eight nations already qualified will be excluded, leaving 16 continental quotas. These 16 continental quotas will be filled by the highest finishing nations in each continental championship that have not already qualified for LA28.</p> <p>Should any nation not accept their invitation to participate in the Qualification Tournament, the next reserve nation will be invited. The reserve nations are determined using the same continental quota system as above, and not by replacing a nation with the next nation in that particular continent. Therefore, the nation from the continent with an eligible team ranked 25th in the FIH World Rankings on 31 August 2026 will be the first reserve.</p> <p>The continental quotas, including reserves, will be published on 1 September 2026. ## E. CONFIRMATION

### Confirmation of qualification places

**E.1.** Following each continental championship and Olympic Qualification Tournament, the FIH will publish the results on its website [Hockey events | FIH](#).

Within 14 days after the completion of the last Olympic Qualification Tournament, the FIH will communicate in writing the confirmation of qualification to the NOC and National Association of each qualified team. The NOCs will then have a further 14 days to confirm if they wish to use these quota places, as detailed in paragraph H. Qualification Timeline.

### Confirmation of host country places

**E.2.** The host NOC must confirm the use of the host country places to the FIH following the publication of this Qualification System on the FIH's and IOC's website.

## F. REALLOCATION

### Reallocation of unused qualification places

#### F.1. FIH Hockey Pro League

If an allocated quota place is not confirmed by the NOC by deadline or is declined by the NOC, the quota place will be reallocated to the next highest placed team in the FIH Pro League Season 8, provided that the team is ranked 20th or higher in the FIH World Rankings at the end of such season. If the team has a ranking of 21st or lower, the quota place will be allocated as below for the FIH Olympic Qualification Tournaments.

#### Continental Qualifications

If an allocated quota place is not confirmed by the NOC by the deadline or is declined by the NOC, the quota place will be reallocated to the next highest placed team in that continental championship, not yet qualified, provided that the team is ranked 20th or higher in the FIH World Rankings at the end of the 2027 Continental Championships. If the team has a ranking of 21st or lower, the quota place will be allocated as below for the Olympic Qualification Tournaments.

#### Olympic Qualification Tournaments

If an allocated quota place is not confirmed by the NOC by the deadline or is declined by the NOC, the quota place will be allocated to the highest ranked team in the FIH Olympic Qualification Tournament that is not yet qualified.

### Reallocation of unused host country places

**F.2.** If the host country does not wish to use its allocated quota place(s) the quota place(s) will be reallocated to the highest ranked team in the FIH Olympic Qualifiers that is not yet qualified.

## G. AP ATHLETES

### Definition

**G.1.** Ap athletes are non-competing athletes accredited in the “Ap” category who have different entitlements from competing athletes (accredited as “Aa”) as described in the Ap accreditation quotas and conditions outlined in the IOC Accreditation Guide. These personnel are not part of the athlete quota as described in paragraph B. Quota Places. Ap alternate athletes could become competing athletes subject to the conditions outlined in the IOC/Los Angeles 2028 Late Athlete Replacement policy.

### Eligibility

**G.2.** Ap alternate athletes must comply with the same eligibility rules as competing athletes as described in above paragraph C. Athlete Eligibility.

### Quota

**G.3.** Each qualified team is entitled to three Ap athletes. In order for a team to be eligible for all three Ap athletes, one of the quotas must be used for a reserve goalkeeper.
