Subject: Request for Permission of Transfer of Membership

The Indonesian Hockey Association ("PHSI") herewith requests permission from the FIH Executive Board to transfer the FIH membership from current FIH Member PHSI to proposed new Member, Indonesian Hockey Federation ("PP FHI") pursuant to article 2.4 a) ii) of the FIH Statutes.

The proposed new Member PP FHI is a party of this application and willing and able to accept the transfer of the FIH membership from PHSI.

Reasoning

After the passing of PHSI President P. Rajkumar Singh, who for many years helmed PHSI with strong leadership and immense personal effort and commitment, the considerably diminished resources and a shortfall of senior officials to take on leadership responsibilities are making sustaining the required levels of administration and operations increasingly difficult.

During the same time these last few years, in parallel, PP FHI has developed into a strong and flourishing organization with a large membership, extensive and well-structured competition and development activities and top-level facilities at its disposal. PP FHI also continues to receive the backing and support of the Indonesian Olympic Committee and the national sports governing bodies of the Republic of Indonesia.

Therefore, PHSI and PP FHI have come to the agreement that the time has come for PP FHI to take over the full responsibility and sole authority to govern Hockey in Indonesia for the benefit of the Indonesian hockey community and the best possible future of the sport in the Republic of Indonesia.
